

RELEASE OF CLAIMS AND INDEMNITY AGREEMENT

NOTICE: A person who is engaged for compensation in the rental of equines or equine equipment or tack or in the instruction of a person in the riding or driving of an equine or in being a passenger upon an equine is not liable for the injury or death of a person involved in equine activities resulting from the inherent risks of equine activities, as defined in section 895.481 (1)(E) of the Wisconsin Statutes.

The undersigned, being of lawful age, desires to participate in equestrian activities at Kinni Valley Riding Academy, LLC, and/or Kinni Valley Riding Stables, Inc., River Falls, Wisconsin. The undersigned acknowledges that there are dangers and risks of injury inherent in these equestrian activities, but still desires to participate in these activities.

THEREFORE, the undersigned, for and in consideration of the opportunity to participate in these equestrian activities and for other good and valuable consideration, does hereby forever release, acquit and forever discharge Kinni Valley Riding Academy, LLC, Mary Carolyn Lowe and Carolyn Laurel, Michael W. Laurel, Kinni Valley Riding Stables, Inc., Thomas D. Lowe, Beverly A. Lowe, their employees, agents and all other persons, corporations, associations, or partnerships in any way involved in said businesses or the owners of land or personal property used in said business from any and all claims, actions, causes of action, demands, rights, damages, and costs whatsoever which the undersigned may have or incur on account of, or in any way growing out of, any and all known and unknown, foreseen or unforeseen, bodily and personal injuries and/or property damage or the consequences thereof resulting from any accident, casualty or event involving the undersigned and arising out of equestrian activities.

IT IS EXPRESSLY UNDERSTOOD by the undersigned that the undersigned would not be permitted to engage in equestrian activities without this release whereby the undersigned, regardless of fault, agrees to fully release the releases from any and all responsibility of accident or injury.

FURTHER, in the consideration of allowing me to participate in such activities, the undersigned hereby expressly agrees to indemnify and save harmless the releases from any and all claims or damages, (including costs and expenses of defending any claims or lawsuits) which might be made against releases by reason of, or in any way arising out of such equestrian activities, including any claims or losses to or caused by other riders, users, guests, invitees or person incidentally involved in the activities or on said premises, or any combination thereof.

The undersigned, further declares and represents that no promise, inducement or agreement not herein expressed has been made to the undersigned and that this release contains the entire agreement between the parties hereto and that the term of this release are contractual and not a mere recital.
